Water audit report discussed.

Water loan payoff. There is a water loan in the amount of \$54,301.21 that we have been paying on since 1992. It was for addition of the water tower and pump stations. If we pay it off by December 1, 2022, we can save approx. \$20,000, since the pay off is not until 2032.

A motion was made by Alderman Jeff Baxter to pay USDA loan in the amount of \$54,301.21 to be taken from the Water Reserve account by December 01, 2022 and seconded by Alderman Donna Staton.

The water meter account has been underfunded since 2015-2016. This has been rolling over since that time. This year the deposit liability should be \$56,064 and the account balance is \$27,932. We have 4 options, move the difference from Water Reserve, make monthly payments until it is funded as it should be, hire an

investigator to see if they can find where the money went or do nothing as has been the case in the past years.

A motion was made by Alderman Jeff Baxter and seconded by Alderman Donna Staton to make monthly payments into the Water Meter account in the amount of \$672 from Water Operations until the water meter account is fully funded.
