Kathy and Lynn completed paperwork to get American Rescue Plan money in the amount of \$93,194.00 to be used for improvements in the water and sewer.

4th of July was fun, there was over \$900 raised for fire department. We had a quilt square judging, bake off and a corn hole tournament.

BIDS for community building repair; The roof is not decked, there is 2x6 across the entire roof and estimates have gone way up. Quote I received yesterday was a little over \$24k.

Rick McClelland passed out letters about water compliance. We had our 2nd quarter samples drawn and I am working on flush program with Kim. We are working on water loss, sewer and flushing and are just trying to tackle one thing at a time.

Police Chief: we received new uniforms and vests.

He was asked how he is going to handle the dogs and Chief states we can write tickets. He was also asked if he had the noose to catch the dogs.

Fire Chief:

Alderman Rowell asked what the \$900 expense was, and Chief stated it was for 2 stihl chainsaws when the storm came thru and blew trees down. This was purchased for fire and rescue with act 833 money.

City Attorney: We received the dismissal on the litigation with the Morrell's/

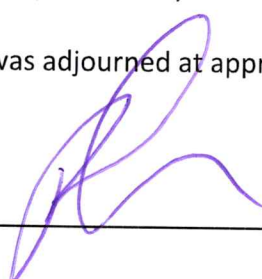
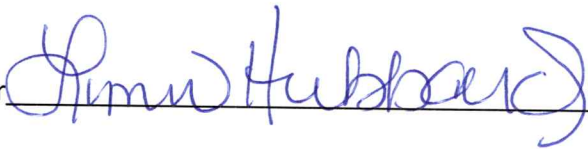
