### 3. Public Forum:

David Goins.....High water bill.

David explained that he uses a lot of water this time of the year but doesn't understand how one meter can use twice as much as the other when they are set on same timer. He said he had problems in the past with his meter and at one time Mayor Richard Leakey even had to write him a check. He went on to explain he went back 3 years and his bills were not this high. Veronica explained that David had a 2 inch and a 3 inch meter and that the 3 inch flow's more volume. She also stated what the reads were as of this morning and the amount of gallons used and that she can't explain where the water goes after it goes through the meter. Alderman Kathy Fry asked David about his greens and if they were really green because we have had an unusually hot June where in the past we had a more wet summer. People don't realize how much they are using.

Ralph Tillery makes motion to table until next month want an average for three years and test both meters. Seconded by Robert Porter. Ralph Tillery yea, Nancy Smith yea Kathy Fry yea, Robert Porter yea, Donna Staton yea. Motion Passes.

Gary Moore.....High water bill continued from last month.

After much discussion with water supervisor and a reminder of the Arkansas Rural water testing on Mr. Moore's meter and found the meter not faulty in fact was giving customer 11% on low flow and that she cannot explain where the water goes once it goes through the meter. Alderman Tillery expressed his opinion of it being a mechanical device nothing is perfect and something could go wrong. Then Alderman Porter asked about the meter being moved while turn on if there could have been a mistake like that. Water Supervisor gave the steps of moving the meter. First the water has to be turned off then meter removed then box dug up and placed in new location. After that line is attached and meter is reset and water service restored. During the discussion, the City Attorney Sean Brister advised that following objective standards with regard to water bill adjustment was preferred to case by case subjective decisions. Alderman Fry ask what about other people that have not got adjusted and the Lee Hackler Lawsuit. She asked if this would be retroactive for past customers that have not received adjustments when asked.

Alderman Ralph Tillery makes a motion to wave \$251.97 of Gary Moore's water bill Seconded by Donna Staton. Ralph Tillery yea, Nancy Smith yea, Kathy Fry NO, Robert Porter abstain, Donna Staton yea. Motion failed.

Robert Porter makes a motion to wave the \$251.97 on the condition stating construction was Being performed by the city and mistakes could have been made. Second By Nancy Smith.
