Mayor Report:

Letters being written to citizens who need to clean their place up will receive a letter from the city giving them 30 days to respond to the letter with a plan to clean up.

We do not have anything in place about the tiny homes and I want to set in place an ordinance outlining the square footage for the older part of town as a city moving forward. The state fire code covers us in that it has approx. 120 sq feet requirement is in place currently.

Evie Goff said she felt that the size should depend on the lot.

Another man spoke up asking about 1000 sq ft on a certain sized lot. Donna Staton stated Arkansas code states 100-400 sq ft.

We are not talking about homes already present. This is new addition. I do not want the city junked up. Joseph Saunders asked about enforcing the ordinances we have. Jeff Baxter asked city attorney if zoning not mean thing. City attorney said you do not have a minimum structure size other than the lot size and minimum size. Jeff Baxter states so what you're saying a person can build a 120 sq ft to in an R1 zone. Mayor asked if they wanted to set minimum sq ft. Much discussion but no decision made to create an ordinance outlining square footage.

Marilyn asked is this what you were using 2 months ago when you said you could not understand all the comments, Mayor said yes, if there is too much talking in the room, and someone is trying to make a point and there is too much talking then she cannot hear the person making the point. Marilyn said maybe you need a better one then. We would like to get a unit that will video and record and put it online. It is pricy but we will get figures on this.

Jessie Valencia discussing with Mayor about placing his homes on his property. He states that Satterfield land surveyor told him he could put it there. He wants to split the lot into 2. He was told if you are going to split a lot in Dyer it will have to go to the Zoning commission. Driveway will be private between 107 and 117 and have the red sign and everything. Alderman Staton told him that if you are doing a subdivision you will have to come to the planning/zoning commission for this. Surveyor said I could put 6 buildings on the lots and be with in code. Where does it say I can't put 6 on there? He was told R1 by several members of council in unison. He states I have 4 lots and I should them on there. Alderman Staton said you have 3 and are they 8500 sq ft each? 120x580 long. Discussion and he was told he has enough for 2.
